Looking for work in Kalmar län?

Formalities

EU/EEA citizens are free to look for employment without any kind of permit for a period of three months. After this, you must have a residence permit. You are entitled to a residence permit if you find employment or have enough funds to support yourself. Information in several languages about work and residence permit is provided by the Swedish Immigration Board (www.migrationsverket.se).

Looking for work

In Sweden, all jobseekers are expected to be active and to make full use of the self-service, job-finding facilities provided, including the Swedish Employment Service home page www.amv.se. The job vacancy database on this website is the most frequently used in Sweden. Vacancies from all over the country are displayed. You can search by region or sector. The employers' contact details are usually included so you can apply directly without having to contact the employment office. The homepage also provides links to other recruitment sites as well as to labour market information. Some of this information is provided in other languages. You should also contact private recruitment companies and temporary employment agencies in your search for work.

Although many Swedes speak English, Swedish employers generally **expect applicants to speak and understand Swedish**, so learning the language as quickly as possible should be a priority. Make full use of any personal contacts you may have. Do not hesitate to contact employers directly, even those who are not advertising vacancies, and market your skills. First job in Sweden?

If you are starting work for the first time in Sweden, and are new to the labour market in this country, you should be aware that the Swedish system for unemployment insurance differs from most other countries.

There is a national scheme providing basic unemployment rates for those who fulfil certain requirements. However, most people contribute to a voluntary insurance system. Information about the system is provided in several languages on www.iaf.se. Most Swedes regardless of profession or trade belong to a trade union. Ask about this at your place of work. If you become unemployed after working in Sweden, but have not worked long enough to qualify for Swedish unemployment benefits, it is possible that work in another country can be taken into consideration. You will find more information about this and about Form E301 at www.iaf.se. If you are unsure about your right to benefits,



you are advised to apply and to provide the insurance office with full details. Application forms are available at the employment office. Decisions about your right to unemployment benefits are made by the insurance offices, not the employment office staff.

Other options

If you have brought a **E303 form** with you from your own country, you will be informed about payment routines and about your contacts with the employment office during the period you look for work in Sweden. You may also have a **E119 form** from your own country covering you for any medical insurance costs incurred during this period. You should contact the employment office and the social insurance office, if you need more information or if sickness prevents you looking for work during this three-month period.

Registering

If you have found employment you should apply as soon as possible to the Swedish Migration Board for a residence permit. If your employment contract is for 1 year or more, your residence permit will be valid for 5 years. If your contract is for a shorter period, you will be issued with a temporary residence permit valid for this period. Please note that it is very common for Swedish employers to offer permanent contracts with up to a 6 months trial period. In such cases the Swedish Migration Board may issue a temporary residence permit. It may be an advantage if EU/EEA citizens say that they intend to stay more than a year. When you have been issued with a residence permit, you then register in person at the local tax office. There you will be issued with an identity number. Those with residence permits for 1 year or more will be issued with a personal identity (*personnummer*). This process is called *folkbokföring*. If the residence permit is for less than a year, you will be issued with a temporary personal identity number (*samordningsnummer*). The *personnummer* is necessary for all kinds of transactions and access to service in society. The *samordningsnummer* serves the same function but not always and not always to the same extent.

Social insurance

After registering at the tax office, new residents should then register in person at the local social insurance office (Försäkringskassan). EU-regulations state that EU/EEA citizens working and/or resident in another member state, shall have access to the same social security and welfare system as Swedish nationals and make no reference to restricted social insurance coverage for temporary residents. EU/EEA citizens with a *samordningsnummer* should therefore ask for full details when registering at the social insurance office. All foreign workers in Sweden should make sure that they fully understand their situation with regard to social insurance. Please note that unemployment benefits are not covered by the Swedish social insurance scheme.

Oskarshamn; international centre for energy experts



Oskarshamn is an energy orientated municipality. A great part of Swedens electrical power is produced 20 km north of Oskarshamn, in OKG's nuclear power plant. Furthermore, Svensk Kärnbränslehantering (SKB) is established on Äspö, a small island situated close to OKGs nuclear power plant. The Äspö Hard Rock Laboratory (HRL) is a unique research facility for geological disposal. SKB performs a series of experiments at a depth of 500 metres together with Swedish and international experts. The purpose of these experiments can range from mapping the flow of water in the rock to the life of microbes. One of the projects scheduled for the coming years is the building of an encapsulation facility. Spent nuclear fuel will be encapsulated in canisters here prior to disposal in the nuclear fuel repository in Forsmark. In addition, SKB plans to build a factory in the municipality for assembling the canisters.

Moreover, SKB conducts a large part of the research on methods and technology, required for long-term safe disposal, in Oskarshamn.

SKB's future in Oskarshamn will obviously offer great conditions for a growing job market for especially engineers, and will certainly have a spin off for the local business climate in general.

Nuclear fuel is deposited at SKB's interim storage facility in Oskarshamn, also called Clab. Today approximately 5,000 tonnes of spent nuclear fuel are temporarily stored in the facility. This is done with constant supervision and control in two storage pool systems 30 metres down in the bedrock. The water shields against radioactivity and cools the hot fuel.

Business life in Mönsterås

Within the municipality there are about 1 200 companies, 100 of which are manufacturing companies, where Mönsterås Bruk, the pulp mill, is the largest. Mönsterås Bruk is the largest producer in the world of paper pulp without chloride chemicals. 75% of the total production is delivered to various European paper mills.

Many more industries in the area are related to forestry, like the sawmill Mönsteråssågan near the pulp mill, and a wide variety of furniture manufacturers with products ranging from complete lecture halls to office chairs. Another speciality is organ building, where the wood and handicraft know-how of the district, combined with the musical interest, comes in handy.

But there's more than wood related manufacturing in Mönsterås. Other existing trades of industry are foundry; steel sandwich products; tool manufacturing; foam plastic; sewage treatment equipment; control equipment, etc. In the service sector, companies offering i.e. advisory ser-



vice in health care, technical support, IT & web solutions and personnel development are among the expanding branches. Niche businesses include the development of base station antennae, burnt almond candy manufacturing, a fish smoker and art pottery.

Gabriel-Keramik AB is a family business which develops, manufactures and markets pottery of stoneware and supply glazed tiles to the tile stove market in Scandinavia.
